



THE ATLAS PROJECT

Investigation Results

Conducted by Detective Georgina Raul & Detective Jamie Caster

SUSPECT

Quill Ragon.

Mr. Ragon's mood began to decline over the next few days. He was described as behaving strangely by fellow crew members, see **evidence 6**. This decline in mood can be attributed to the falling stock price of his company which was recorded in the newspapers, see **evidence 7**.

Mr. Ragon also likely lied about a phone conversation he had with his father. As seen in **evidence 8**. This is confirmed in the note Artis Ragon wrote and Quill Ragon hid inside his pen. See **evidence 9**.

Mr. Ragon also lied to investigators about working in the morning. He claims he logged into work but there is no evidence of this in the AI Log. See **evidence 19**.

Finally, Mr. Ragon is trained as an AI Specialist meaning he can use the AI System aboard the SunSpear. See **evidence 10**. Drew Biggs explained to Investigators that only someone with AI training can use the system the way it was used to cover up their movements. See **evidence 11**.

MOTIVE

Mr. Ragon's company was threatened by the new research and project The Atlas Project was working on and so therefore took the opportunity to steal or destroy the research. His father insisted he acted.

Mr. Ragon had a clear conflict of interest in the research being conducted aboard the SunSpear under Captain Jordan's command. He is due to be the next CEO of Ragon Industries a transport company as seen in **evidence 1**. There also appears to have been some concerns surrounding his employment, see **evidence 2**. This is further supported in the same news article that states that Quill's position was granted by Captain Jordan. See **evidence 3**. The Atlas Project clearly had concerns surrounding Quill's presence and potential of conflict since the project was to research wormhole theory which likely would negatively impact Ragon Industries, the current leader in galactic transportation. **Evidence 4** explains the benefits to wormhole travel. **Evidence 5** suggests that other travel companies are beginning to panic.

METHOD

Mr. Ragon suffocated the captain by using the emergency lock on the Captains' Quarters door which removes the air flow to the room. Quill then used his AI Specialist training to remove his movements from the AI Log. He then destroyed the data card.

Trix Morgan noted that Quill was still awake at an unusual time. See **evidence 16**.

Mr. Ragon has light bruising on his arm from where he pushed the captain back into the Captains' Quarters. See **evidence 20**.

Mr. Ragon claims to have not intended the death of the captain by his own admission. However, the captain still died due to his actions. Quill, intentionally or not, used the emergency lock on the Captains' Quarters door. This lock is explained in more detail in the SunSpear Ship Navigation Map. See **evidence 12**. The lock was activated by Quill as seen in the AI Log. See **evidence 13**. Adora Au explains in her interview what the error messages relate too, see **evidence 14**.

In using the emergency lock, it causes the Captains' Quarters to depressurise and also remove the air flow in order for the rest of the ship to conserve oxygen. While it cannot be concluded via an autopsy that suffocation was the cause of death due to suffocation being difficult to detect; it does appear clear that suffocation due to a lack of oxygen is the most likely cause of death in this case due to the circumstances. See **evidence 15**.

Mr. Ragon then used his AI Specialist training, see **evidence 10**, to remove his movements and conduct a maintenance run on the AI to give himself ten minutes without being recorded by the AI.

He then returned to the Captains' Quarters and placed Captain Jordan in his bed, in a rush he left the scene, not having time to clean the small amount of blood off the door and floor. See **evidence 17**.

After this he returned to the Crew Quarters and in the morning on hearing Trix was contacting authorities he attempted to destroy the data card and hid the pen with the message in a hurry in the air duct next to his cabin. See **evidence 9** and **evidence 18**.
